In 2012, the following seminars will be offered:

- **First Steps to Financial Security:** Provides a basic overview of financial tools such as budgeting and debt management with an emphasis on long-term planning. Appropriate for employees starting out early in their career. **(Approximately 60 Minutes)**
- **Deferred Compensation and Cash Match Plans Overview:** Provides an overview of Plan provisions, features and benefits. Appropriate for all employees that are eligible for the Deferred Compensation and Cash Match Plans. **(Approximately 45 minutes)**
- **Understanding Your Plan Investments:** Reviews basic investment principles, provides an overview of the options available within the Plans, and an explanation of investment performance and account statements. Appropriate for all employees. **(Approximately 75 minutes)**
- **Retirement Distribution Strategies:** Reviews the Plans' distribution options and provides information on potential taxes and penalties. Appropriate for participants nearing retirement or retirees. **(Approximately 75 minutes)**
